#### I. <u>CONTEXT AND JUSTIFICATION</u>

One of the goals stated by the founders of OHADA is to boost economic growth in the member States through private investment, whether national or international. Alternative dispute resolution methods, such as arbitration and mediation, are the preferred methods for resolving commercial disputes.

Following the 2017 reform, which reaffirmed the importance of investment arbitration, and the adoption of the Uniform Act on Mediation, OHADA Institutional Arbitration has entered a phase of renewal. With this reform, which takes account of international standards in this area, the Arbitration Centre of the Common Court of Justice and Arbitration (CCJA) will be in a better position to achieve its objectives and place Abidjan at the center of OHADA Arbitration, making it a major centre alongside other international arbitration centers..

With regard to the African Continental Free Trade Area (ACFTA), it was created by the Assembly of Heads of State and Government of the African Union (AU) with the aim of strengthening economic relations between AU member States and fostering their development through the creation of a large integrated African market. It represents a trading area covering more than 1.2 billion people, spread across the 55 member States of the African Union (AU).

It aims to ensure the free movement of goods, services, people and investment.

On 29 April 2019, the threshold of 22 countries ratifying the Agreement was reached, enabling the Agreement establishing the ACFTA to enter into force on 1 January 2021. The entry into force of the ACFTA will, on the one hand, contribute to the development of the African continent and, on the other, will certainly generate trade and investment disputes.

It is therefore important to know how OHADA, of which all the member States are also members of ACFTA, will be able to offer an effective alternative, if necessary, to resolve disputes that are not covered by the dispute settlement mechanism provided for by ACFTA

The 2nd edition of the African Arbitration and Mediation Days, placed under the High Patronage of Mr Jean SANSAN KAMBILE, Keeper of the Seals and Minister of Justice of the republic of Côte d'Ivoire, and organised by the CCJA in partnership with the APAA, NiCarb and ERSUMA, desirous, on the one hand, to identify the disputes likely to arise with the effective creation of this vast integrated African market and, on the other hand, to present both African and non-African offers for the alternative settlement of the said disputes.

#### II. <u>OBJECTIVES</u>

#### A. GENERAL OBJECTIVE

To prepare the arbitration community of OHADA member States and other countries to the reform of the CCJA arbitration system, and to train them to deal with the settlement of commercial and investment disputes that will arise following the implementation of the ACFTA, in connection with this reform.

#### **B.** SPECIFIC OBJECTIVE

More specifically, the 2<sup>nd</sup> edition of the African arbitration and mediation days aims to:

- Specify the scope of the reform of the OHADA arbitration and mediation system;
- identify the types of disputes likely to arise in the context of the effective implementation of the ACFTA;
- provide an understanding of the dispute settlement mechanisms provided for in the Protocol on Dispute Settlement;
- determine the interferences between the Dispute Settlement Body (DSB) provided for by the Protocol on Dispute Settlement and ad hoc or institutional arbitration, as well as mediation/conciliation with regard to the parties involved, i.e. States, economic operators and investors.

#### III. <u>TARGET PUBLIC</u>

The 2nd edition of the African Arbitration and Mediation Days is intended for actors involved in trade within the OHADA area and in the deployment of investments arising from the implementation of the ACFTA, as well as those who are concerned, directly or indirectly, by the settlement of disputes arising from the Agreement. This includes in particular ::

- executives in charge of States disputes and other legal entities governed by public law;
- managers and executives of African community economic and legal integration organisations;
- directors, managers and executives of private organisations ;
- magistrates, lawyers, notary public and court officers ;
- economic operators;
- in-house counsels;
- managers and executives of arbitration and mediation institutions;
- researchers in the field of trade and international disputes;
- students and trainees in the field of commercial law and international litigation.

#### IV. <u>CONFERENCE LANGUAGES</u>

The sessions will be conducted in English and French, with simultaneous translation into Spanish and Portuguese, then into English and French.

#### V. <u>ANIMATION</u>

This 2nd edition of the African Arbitration and Mediation Days is organised by the CCJA/OHADA, in partnership with the APAA, NiCarb and ERSUMA.

It will be led by eminent specialists in dispute resolution, international experts and institutional partners.
